## **Plan Descriptions**

A description of how parents, teachers, and school staff were involved in the development of the plan.

In order to better understand the needs of our student populations, we held regular meetings on the topics of student needs and possible solutions. In addition, a survey was conducted which was distributed to parents, teachers, families, and additional support staff. In this manner we sought to include the voice of multiple stakeholders in order to ensure that our plan was responsive to student and family needs.

A description of how students will be identified and the needs of students will be assessed.

Students that need additional support will be identified through several diagnostic assessments that will be administered at the beginning, middle, and end of the school year. In addition, teachers will be given opportunities to identify students that need additional supports and are struggling academically. Lastly, students that need specific support due to being identified as an English language learner or a student with disabilities will be prioritized as students that will also receive additional academic growth opportunities.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Parents and students will be notified through numerous methods. Parents will be messaged directly via phone call and text regarding opportunities, and general posts will be made on the Class Dojo school website. Lastly, parents will be given direct follow-up phone calls in order to assist parents signing up for the various opportunities provided.

A description of the LEA's plan to provide supplemental instruction and support.

We will continue to provide support for students via non-teaching support staff that will help students continue to participate in online distance learning. In addition we will be providing supplemental instruction via partnering with outside organizations to give our students necessary interventions. Students were identified through a data-analysis process that presented groups of students that needed support in either/both English Language Arts and Mathematics. These students were then grouped and were provided small-group intervention instruction to help close learning gaps, learning gaps that were identified through diagnostic testing of students. These students were also identified and invited to attend up to six weeks of summer school programming.l.

Lastly, our entire student body was invited to summer school as part of an effort to provide them with programs that will close academic gaps students have demonstrated through distance learning. This would target current students and all students that are matriculating into the school. This will allow us to identify student and social emotional needs before the start of the school year; allowing us to provide students academic and whole-child support to ensure they start the school year in the most successful way possible.

As part of a larger teacher support plan, teachers will be provided additional professional development to continue honing and improving skills to help ensure a successful transition back to in-person instruction. Specifically, funding will be allocated to hire an intervention teacher. The intervention teacher will work with students that have persistent gaps in their learning. They will also provide teachers with dedicated professional development on strategies that are most impactful for students.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

In planning for the months and years ahead, the LEA is implementing programming that will have both immediate and longer-term impact on the students we serve, nearly all of whom meet the parameters indicated in the ELO grant opportunity. The learning recovery plans described here were developed in coordination with the other funding sources (for example, ESSER and ESSER II) to maximize and optimize the programs and services that students receive. The LEA is using ESSER funds to further support increased levels of direct services for students, including, but not limited to, additional school staff to decrease student/staff ratios, additional small-group intervention opportunities during, before and after the regular school day, summer and vacation programming and increased availability of comprehensive, wrap-around supportive services.

#### **Instructions: Plan Requirements**

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in
  accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student
  supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

• "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.

7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

#### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
