PARENTS

LEA maintains parent advisory committees that provides input into the schools' programs and services for students. The School Site Council (SSC) and English Learners Advisory Committee (ELAC) meets regularly throughout the school year- ELAC on Tuesdays/SSC on Thursdays. Each committee is composed of elected parents-10 on ELAC and 5 on SSC. The principal, Student Support and Success Coordinator, Instructional Leadership Teams (ILT) grade level leads, Learning Academy Coordinator, teachers, and other school support staff attend these monthly meetings. The purpose of these committees is to engage parents in the LCAP and Single Plan for Student Achievement goal(s) review and planning process, to elicit their input into the school's programs and services for students, and to provide them with the opportunity to voice priorities for their students. ELAC is comprised of parents of students who are English learners and school leadership. At each ELAC meeting, members receive information and provide recommendations on the development and implementation of the programs and services that support the school's students who are English learners. ELAC

reviews the achievement and progress of EL students in detail, including the California School Dashboard English Learner Progress Indicator and Chronic Absenteeism Indicators. ELAC receives information on the school's reclassification procedures and rates, along with other data including data relating to the metrics that are part of the state's priorities. Members receive information and provide recommendations on programs and services for English learners. ELAC members review EL student achievement and provide recommendations as to how the school's programs can be improved to increase the achievement of ELs. The ELAC then reports to the SSC right after their meeting.

The SSC made the following recommendations regarding the Extended Learning Opportunities Grant funding:

• Maintain or expand programs and services for students, especially students who are low-income, English learners, and/or foster youth.

• Continue to provide services and programs that support students' social/emotional health and well-being

• Have accountability in place to ensure that supports are reaching students and are effective in decreasing absenteeism

• Provide outreach, training, and support for parents in parenting skills and strategies that support the social/emotional well-being of their childrenIdentify groups of students, especially high-risk students, who are improving and replicate strategies and supports that were given to these students to other high-risk student groups.

• Increase services for at risk students and/or student groups including after school extended school program and summer enrichment programs.

• Support parent awareness of available interventions, enrichment and support using ClassDojo, school website, Learning with the Principal and other communication tools, ensuring families can make use of available resources.

Teachers/School Staff

Monthly Staff Meetings will support the review of our school goals and what the data has indicated are our gains/growths. During Instructional Leadership (grade level) dialogued and discussed specific grade level needs to meet school goals.

We will continue to use our problem solving cycle- Analyze-Diagnose-Design-Actions to identify the needs of students. After each assessment cycle, create our plan with the support of Here's What? So What? Now What? Teachers complete Target Student Plans-where they select 5-6 students they will monitor progress every 2-3 weeks to ensure instructional practices need to be shifted.

Support parent awareness of available interventions, enrichment and support using ClassDojo, school website, monthly Learning with the principal monthly meetings, teacher workshops and other communication tools, ensuring families can make use of available resources.

LEA will provide supplemental instruction and support to students by extending instructional learning time.

The LEA will provide an effective summer tutoring program during the grant period. Credentialed teachers and instructional assistants will provide intensive instruction/intervention to small groups of students. After-school tutoring/intervention will be provided to identified students during the regular school year throughout the grant period. Tutoring will be provided to small groups of students and will focus on ELA and math. Professional development in foundational skills and math training will be provided to teachers and support staff.

LEA will provide integrated support to students in grades TK-2 with instructional assistants. They will work in classrooms providing supports which includes, but not limited to, small group instruction and one-on-one student support in ELA, math and additional content areas.

LEA will collaborate with our mental health services and community partner to provide additional professional development opportunities for teaching and support staff, especially in the areas of supporting students' social-emotional needs.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

In planning for the months and years ahead, the LEA is implementing programming that will have both immediate and longer-term impact on the students we serve, nearly all of whom meet the parameters indicated in the ELO grant opportunity. The learning recovery plans described here were developed in coordination with the other funding sources (for example, ESSER and ESSER II) to maximize and optimize the programs and services that students receive. The LEA is using ESSER funds to further support increased levels of direct services for students, including, but not limited to, additional school staff to decrease student/staff ratios, additional small-group intervention opportunities during, before and after the regular school day, summer and vacation programming and increased availability of comprehensive, wrap-around supportive services.

Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in
 accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student
 supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

• "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.

7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
