





Develop and adopt a plan delineating how the Educator Effectiveness funds will be spent to provide professional learning for teachers, administrators and paraprofessionals who work with pupils, and classified staff that interact with pupils. 2. What process will you use to engage education partners on how to use the ELO-Program (summer school, intersession, afterschool)?

Future monthly meetings ranging from February – May 2022 are scheduled to engage education partners in how to use the ELO Program funding. These meetings include: Café de padres (Parent Information Meetings); School Site Council, English Learners Advisory Council, Instructional Leadership Team meetings, Teacher/Staff meetings. Academic and behavioral data will be shared to inform the education partners in the decision-making process.

3. How were educational partners engaged in the use of ELO-Grant dollars (e.g. "Additional Aides for Intervention, Trying to hire Intervention Coordinator, Tutoring & Other consultant supports, See ELO-G Plan for more details")? Funds were included in FY22 Budget, so should have been included in FY22 LCAP engagement process.

During May 2021 meetings were held to engage education partners in determining how to use the ELO-Grant funds. These meetings include: Café de padres; School Site Council, English Learners Advisory Council, and teacher/staff meetings. Education partners determined that additional hours for Instructional Assistants were needed to provide support for students in intervention/tutoring; additional instructional materials for intervention; and support for social-emotional wellness, including a Social Worker position. Funds were also used to retain staff despite lower enrolment. At these continuing monthly meetings, PLN CMS will share academic benchmark data to continue to inform decision-making with funding and make any adjustments necessary. Data will include behavioral data to inform social-emotional development.

A description of how the LEA used, or plans to use, the additional concentration grant add-on funding it received to increase the number of staff who provide direct services to students on school campuses with an enrollment of students who are low-income, English learners, and/or foster youth that is greater than 55 percent.

The LEA made a decision to provide a designated supports for our English Language Learners (ELL). An addition, of a staff member to provide regular instruction in English Language Development to address reclassification rates. Approximately one third of the school is identified as an ELL and requires regular instruction to develop grade level skills in reading, writing, speaking and listening in English.

A description of how and when the LEA engaged its educational partners on the use of one-time federal funds received that are intended to support recovery from the COVID-19 pandemic and the impacts of distance learning on pupils.

What process was used to engage education partners for ESSER III Plan & ESSER funds in FY22 LCAP process? Be specific with dates where possible: Per EdTec, this is how those funds were used:

- During Instructional Leadership Team (ILT) meetings on a bi-weekly basis curriculum implementation decisions were discussed. Specifically, regarding the I-Ready dynamic assessment system. The LEA purchases chrome books, hotspots, replacement chargers and charging stations to support student learning. The chrome books were purchased intently to facilitate student learning remotely and in person. Throughout the year we have experienced a great degree of usage for technology as education partners responded to the safety precautions installed to ensure safe learning for all.
- Staffing additions were made in the area of Special education, occupational therapy, social worker, speech &language pathologist Director of curriculum, Technology Coordinator and School psychologist, Instructional Assistants, Campus Assistants. All positions were added and or enhanced to provide support for student learning.
- The LEA purchased PPE for education partners to use while learning in person. Specifically, Plexi-glass dividers were
 purchased and installed on all classroom desks so students could sit safely. In addition, high quality masks, hand sanitizer
 stations and single water use stations were purchased and maintained for staff and students. We have also contracted with a
 school nurse provider to support the school for 3+ days per week. Regular PCR testing has been and will continue to be
 performed every week for staff and students.
- The school has contracted with the local Business Improvement District team to provide daily external cleaning and security on the campus. This has promoted less transient activity around the campus.

A description of how the LEA is implementing the federal American Rescue Plan Act and federal Elementary and Secondary School Emergency Relief expenditure plan, and the successes and challenges experienced during implementation.

LEA purchased Personal Protective Equipment for all staff and students to reduce the spread of the COVID-19 virus. Each school was provided with masks for students and staff, Isolation Room PPE Boxes (face shields, gloves, shoe booties, isolation gowns), screening equipment (rolling plexiglass screens, cones, temperature check devices, sidewalk signs), plexiglass installed in high foot traffic areas, hand sanitizing stations, disinfection solution, and outdoor/indoor signage.

- a. <u>ELO-Grant</u>: Additional Aides for Intervention Trying to hire Intervention Coordinator Tutoring & Other consultant supports See ELO-G Plan for more details
- b. LCAP Concentration: additional ELD teacher hired.
- c. <u>Curriculum, Books, and Technology</u>: To address the academic impact of lost instructional time the LEA purchased a new Student Information System that allows families access to student attendance, grades, and an overview of performance on assignments. The LEA also purchased a new intervention program for their ELD instruction, the English 3D program by Houghton Mifflin Harcourt. Finally, the LEA purchased the Second Step curriculum to provide students and teachers with a research-based resource they can leverage during the daily Advisory period.
- d. <u>Interventions</u>: To address the academic impact of lost instructional time the LEA invested in a variety of interventions to support staff, students and families. These interventions include Social Emotional Wellness training to align our staff community's understanding of the central role that the student's lived experiences play in their academic journey. The LEA also invested in a Thanksgiving Break camp intended to offer students an academic and enrichment program for three days of the Thanksgiving holiday. The LEA also invested in a reading intervention tutoring program called Tutored by Teachers. As part of this work up to 100 students will receive weekly small group and one-on-one reading and math tutoring from credentialed teachers to address learning loss and get them closer to grade-level proficiency.
- e. <u>Special Education and Central Staff Supports</u>: The LEA intends to hire a Student Information Systems (SIS) Coordinator to help with the implementation of our new SIS platform and maximize effectiveness of the investment. This action plan also includes staffing Special Education Instructional Assistants and a School Psychologist to support the nearly 16% of Charter Middle School students who receive Special Education services.
- f. <u>Intervention Coordinator</u>: The LEA endeavored to hire an Intervention Coordinator to support with data analysis, intervention groupings, training of Instructional Aides to conduct intervention, and management of external intervention partners (e.g., Tutored by Teachers) to ensure all students are receiving academic programming that addresses their unique learning needs. Unfortunately, the LEA has been unable to make a hire in this current market.
- g. <u>Instructional Aides</u>: The LEA endeavored to hire 21 Special Education, Campus, and Instructional Aides to support the academic and social emotional development of all students on campus. This staff model creates an adult to student ratio of 1:7 on the Charter Middle School campus; increasing the likelihood that each student has a positive relationship with at least one caring adult on campus. Unfortunately, the LEA has only been able to achieve a high of 15 hires.
- h. <u>Social Worker</u>: The LEA is hiring a School Social Worker to provide individual, group and family counseling. This staff member will also serve as part of the crisis intervention team; assessing Tier 1 and 2 incidents. The School Social Worker will case manage and provide support on Tier 3 incidents in collaboration with school leadership.
- i. <u>Professional Development in Social Emotional Wellness</u>: Ongoing professional development with all school-based staff to deepen our knowledge of how to best support the social, emotional, and mental health needs of students. Sessions will be facilitated by Social Work staff and designed in collaboration with the school's principal. Content for training will leverage the CASEL Framework for Social Emotional Learning.
- j. <u>Academic Progress Monitoring</u>: School staff will intentionally progress monitor student academic progress in ELA and Math at four distinct points throughout the year. The progress monitoring windows will include administration of the i–Ready Standards Mastery quizzes and i-Ready diagnostics. Data will be reviewed by teachers to determine appropriate student groupings for intervention classes built into the instructional day.

k.	School Support Services: A cross section of teachers, school administrators, counselors, therapists, After School Program staff, Special Education administrators, and Social Workers will meet monthly to case manage, determine measurable interventions, communicate with referring staff, and arrange for ongoing supervision to support and monitor progress.

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Para Los Niños Charter Middle School (PLN CMS) is located in the heart of industrial downtown Los Angeles. Our school sits on the edges of the Fashion, Flower and Fruit and Produce districts of downtown. Our neighborhood is Skid Row. The middle school is co-located with LAUSD's 9th street elementary school. This is PLN CMS's 8th year at its current location. It has been in operation for 10 years and began as a 6th grade cohort at the flagship Para Los Niños Charter Elementary school located a mile away on 7th and Alameda Blvd. PLN CMS was generated from a demand to provide a quality middle school education to the students and families that present atpromise needs. Our school serves families that commute from all across Los Angeles County to work and operate their businesses downtown, families that live in historic South Central Los Angeles, East Los Angeles and the Pico Union District. In addition, we serve the most at-promise families that are living temporarily at the missions and transitional housing in Skid Row. Our school is a popular choice among families due to our consistent academic program, comprehensive sports program and supportive after school program.

Para Los Niños Charter Middle School is a cornerstone for working families in Downtown Los Angeles and a learning haven for children who have experienced multiple stressors in their lives; 92% of whom are socioeconomically disadvantaged. Through a relationship-based approach and Multi-Tiered System of Support, we provide an educational program that addresses the academic, social and emotional learning and, ultimately, the wellness of our students. We have an intense focus on the whole child, understanding that children live and learn within the context of a family, and a family lives and learns within the context of a community. As part of a non-profit organization, we strive to personalize our educational approach for every student by providing comprehensive and accessible support in our schools which begin from infancy and range to middle school. We are in constant pursuit of accelerated learning, through assessment and data-driven data decision-making. Through an interdisciplinary, arts-infused approach to mastery of grade level standards, our students – the overwhelming majority of whom are English Learners – are provided with multiple ways to succeed and express their learning. With a foundation of constructivist learning theory, PLN CS believes that deeper, active and engaged learning builds on students' lived experience and knowledge and encourages inquiry and exploration. We are in pursuit of creating a more culturally relevant educational experience for students by integrating social justice themes. Through inquiry in NGSS topics we also promote relevance, critical thinking and standards-based rigor in the lives of our students.

Sheltered English is our current approach for our English Learners. We aim to provide a greater level of rigor through a structured, standards-based literacy program that builds on inquiry while developing strong foundational reading skills. We are working collaboratively as an organization to support staff and students in their development of CASEL competencies. We personalize support by working in partnership with families. We aim to create a personalized experience for the child and family through the interdisciplinary work of educators

and staff in Social Work, Mental Health, and our Afterschool Program. Working collaboratively as an organization, we seek to unlock the potential of every child and promote powerful families and communities.

MISSION

The mission of the Para Los Niños Charter Middle School is to help children in grades 6-8 and their families succeed in school and in life. In keeping with the vision for Para Los Niños as an organization, our school is a center for urban education providing students and their families with all the support and tools necessary to ensure academic success.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

This past school year, Para Los Niños Charter Middle School implemented social-emotional support for students, through whole class, small group, and individual work focused on relationship building practices. With the implementation of Positive Behavioral Interventions Support (PBIS), our students are learning life skills to overcome challenges and gain success, impacting both school and work climates.

PBIS is a proactive approach to improve student outcomes by supporting students with positive preventative behavior rather than punishment. For educators, it is not a curriculum to learn and teach but instead, a commitment to establishing behavioral and cultural supports needed for any student to achieve academic and emotional success. PBIS is a three-tiered framework that supports students in multiple ways. When implemented effectively, students experience greater academic success, schools experience less of a need for exclusionary practices like suspension or expulsion, and teachers and staff often feel more effective. Each tier reflects a particular system of support that in unison operate to improve student outcomes across every aspect of their lives.

For the 2022-23 school year, the Charter Middle School will continue to deepen PBIS practices and start training on restorative practices with the California Conference for Equality and Justice. Additionally, our PBIS team will participate in the PBIS Cohort training and Community of Practice at the Los Angeles County Office of Education (LACOE), to strengthen PBIS implementation schoolwide with fidelity. Additionally, we have hired a Social Justice Project Coordinator to provide oversight to all aspects of our tiered levels of supports and interventions in creating a safe, inclusive, respectful school community.

Academic elective blocks, that focused on foundational math and literacy skill development. Students were identified based on baseline i-Ready assessments and feedback from teachers. The purpose was to accelerate student progress towards grade level mastery in reading comprehension and math number sense. For the 2022 -23 school year, we will continue to train teachers on implementing phonics instruction to address identified student needs that include issues with decoding and vocabulary and number fact fluency that includes training on cognitively guided math instruction.

In the 2021-2022 school year, the Charter Middle School decided on the implementation of a designated English Language Development (dELD) course with a standalone teacher. The implementation of a designated ELD program led to tremendous growth and development for English Learner (EL) students. This school year we had a reclassification rate of about 27%, or 34 out of 126 EL students, compared to the 2020-2021 school year which had a reclassification rate of about 2%, or 3 out of 124 EL students. Additionally, our English Language Proficiency Assessment for California (ELPAC) passing rate was 31%, or 39 out of 126 EL students, compared to the 2020-2021 school year's passing rate of about 9%, or 11 out of 124 EL students.

Reflections: Identified Need

The following chart reflects Para Los Niños Charter Middle School's Fall 2019 CA School Dashboard results. As a result of the COVID-19 pandemic, and the governor's orders to suspend state testing, the CDE has not released a School Dashboard since Fall 2019. Performance levels for Suspension Rate reflected a yellow performance level schoolwide and for numerically significant groups of Socioeconomically Disadvantaged and Hispanic students. English Learners and Students with Disabilities experienced Suspension Rates at the orange performance level.

The shift to remote learning that took place as a result of the COVID-19 pandemic has had clear negative impacts on our students' health, social and cognitive

development, mental health, and overall academic achievement especially among English Learners (EL), low-income, and Students with Disabilities (SWD).

Our school has taken a multi-tiered approach to address these identified needs while also faced with high rates of absenteeism and quarantines due to infection rates and/or in adherence to state and county COVID-19 health and safety protocols which constantly changed throughout the year. It was critical to measure the impact the pandemic/remote learning had on our students reading and math proficiency to assess and identify student academic needs.

In the 2021-22 school year, i-Ready assessments were administered in-person to all students as a diagnostic assessment at the beginning of the school year (fall), mid-year (winter) and end of year (spring), to assess student academic needs and target instruction.

The following charts reflect English Learner (EL) student performance (growth) from fall 2021 to spring 2022 in reading as measured using i-Ready assessments.

Analyzing Fall 2021 to Spring 2022 results:


Approximately 30 out of 101 EL students advanced from performing at 2+ grade levels below, to 1 or fewer grade levels below, in reading. A total of 6 out of 9 students advanced from performing at 1 grade level below, to at or above grade level.

For the 2022-23 school year, there is a need to strengthen EL academic performance and language acquisition and proficiency. Our teachers will engage in professional development opportunities that center around designated ELD learning structures that provide opportunities for EL students to practice listening and speaking skills. There is also a need to ensure teachers differentiate/scaffold instruction to support the learning needs of our English Learners and Students with Disabilities. An ELD credentialed teacher will be hired to solely teach designated ELD courses by level, ensure language needs are being met, and collaborate with teachers on strategies to support ELs.

i-Ready assessment findings were analyzed and presented to staff and parents. The findings were also used to inform instruction, identify intervention needs, and inform use of supplemental instructional materials. These findings were also used in our needs assessment and consultation with our educational partners in the development of the 2022-23 LCAP. There is a significant need to strengthen and expand reading intervention to reduce achievement gaps among Unduplicated pupils.

The following charts reflect overall placement (performance) for students in Math from fall 2021 to spring 2022, and placement by domain.

There is also a need to improve Math instruction and strengthen vertical alignment. As evidenced in the i-Ready assessments, 90% of our students are performing at least one year below grade level. We will hire a Director, Secondary Education that will coach and collaborate with our math teachers. They will also provide professional development on the use of instructional materials. The Director, Curriculum, Instruction, and Assessment will meet with the Charter Middle School Leadership Team to conduct a needs assessment for new math curricula.

Para Los Niños Charter Middle School continues to implement and expand its Multi-tiered System of Supports (MTSS). MTSS is an integrated, comprehensive framework that focuses on Common Core State Standards (CCSS), core instruction, differentiated learning, student-centered learning, individualized student needs, and the alignment of systems necessary for all students' academic, behavioral, and social success.

MTSS is a framework that brings together both RtI and PBIS, and aligns their supports to serve the whole child, it also relies on data gathering through universal

screening, data-driven decision making, and problem-solving teams, and focuses on content standards. MTSS aligns the entire system of initiatives, supports, and resources, and implements continuous improvement processes throughout the system.

Rtl is an approach that focuses on individual students who are struggling academically and pulls together resources from the LEA, school, and community to promote students' success before they fall behind. It is systematic and data-driven with tiered levels of intervention to benefit every student.

PBIS is an approach that focuses on the emotional and behavioral learning of students, which leads to an increase in engagement and a decrease in problematic behavior over time. It assists the LEA in adopting and organizing evidence-based behavioral interventions that improve social and emotional behavior outcomes for all students.

This school year we continued to build our intervention program based on conversations and regular meetings with educational partners. These meetings occurred monthly in order ensure parents had regular opportunities to provide their feedback. These meetings included parents from various demographic groups, including parents of EL students as well as Students with Disabilities.

Based on feedback from these partners, PLN Charter Middle School implemented an academic intervention block into our school day. This elective block focused on foundational math and literacy skill development. Students were identified based on baseline i-Ready assessments and feedback from teachers. The purpose was to accelerate student progress towards grade level mastery in reading comprehension and math number sense. For the 2022-23 school year, we will continue to train teachers on implementing phonics instruction to address identified student needs that include issues with decoding and vocabulary and number fact fluency that includes training on cognitively guided math instruction.

PLN Charter Middle School also hired a credentialed ELD teacher to teach designated ELD (dELD) to students. Students in these courses leveraged the English 3D curricula from Houghton Mifflin Harcourt. Thanks to the work done in these classes, and the integrated ELD (iELD) supports provided by core instructional teachers, PLN Charter Middle School had more than 30 students reclassify and Fluent English Proficient. For the 2022-2023 school year, we will continue to leverage dELD support for our students. In addition, the school will provide professional development to Instructional Assistants, so they have greater skill and clarity on how to support English Language learner students in the dELD and iELD settings.

Finally, PLN Charter Middle School will contract with a third-party provider, Tutored by Teachers, to provide small group English and Math tutoring sessions. These sessions will be offered during the school day via the Zoom meeting platform. Classroom teachers will work as blended learning instructors twice a week to support students as they work in groups of three-to-five students. Students will be identify based on baseline i-Ready assessments and feedback from teachers.

Monitoring and Evaluating Effectiveness

As part of our intervention process, we are also implementing a monitoring system to ensure that work we are doing with students gives us positive results. For the 2022-2023 school year we will continue using i-Ready as a tool to establish a baseline of student abilities. We will also leverage i-Ready to administer monthly Standards Mastery assessments. These assessments will help us continue our monitoring process and ensure that students are making the necessary growth. After cycles of intervention take place, the data will be reviewed, and education partners will continue to provide feedback as we continue to refine our process. Effectiveness will be monitored through defined periodic checks in the data to make sure that the selected students are progressing and making academic gains as expected.

Engaging Educational Partners

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

The following is a summary of the engagement process Para Los Niños Charter Middle School used to involve our statutorily required educational partners in the development of the LCAP and how this engagement was considered before finalizing the LCAP. Engagement of our educational partners has been an ongoing process throughout the academic school year with the development of the multitude of school plans as outlined in the LCAP supplement.

- Teachers met weekly during virtual and in-person staff/professional development meetings, and discussed student academic assessment data, PBIS update and planning, English Learning Coordinator Professional development, use of one-time funds, and 2022-23 PD planning.
- Principals/Administrators met weekly in-person and virtually to discuss attendance, behavior, COVID-19 protocols, Health & safety issues, intervention, i-Ready assessments, reclassification, professional development needs, use of one-time funds, budget, and parent workshops.
- Other School Personnel– COVID Task Force took place weekly both virtually and in-person. Discussions took place on COVID testing protocols and procedures, progress reports, infection rates/quarantine, parent events, staffing, Panorama survey results, and use of one-time funds.
- Parents including those representing Unduplicated Pupils (UP) and Students with Disabilities (SWD): meetings took place monthly via zoom (virtually). feedback on ways to engage parents during a pandemic, opportunities for community engagement, volunteering opportunities, use of one-time funds, parents had concerns about COVID protocols, about homework policies about students need for academic support.
- Students including Unduplicated Pupils and Students with Disabilities (SWD) meetings took place in-person during monthly townhalls meetings, weekly advisory circles, and an annual survey via Panorama survey. Discussions took place on COVID protocols.
- ELAC: took place every other month virtually and discussion greater understanding of what English learners are, the process for reclassification, understanding of the ELPAC and how the school is working to support them.
- School Site Council (SSC) including parents of UP and SWD: took place monthly virtually. Parents provided feedback through diverse lenses and allowed for discourse around COVID policies, grading, assessment, uniform, fundraising, bullying and counseling support.

A summary of the feedback provided by specific educational partners.

The following is a summary of the feedback provided by the following required educational partners, that emerged from an analysis of the input received in the development of the 2022-23 LCAP.

- Teachers stated they need more support, training, resources to support English Learners and Students with Disabilities (SWD). Teachers shared concerns on COVID protocols and safety; and would like more consistency and structure with the SSPT/MTSS. Teachers would like to continue with School Support Service meetings, but felt it wasn't sufficient time to discuss student needs.
- Principals/Administrators: feedback was focused on the need for robust professional development for Administrators to build capacity and strengthen their skillset as coaches, professional development for teachers on: CGI Math; phonics instruction; ELD; reading strategies; and Restorative Justice. Feedback from the Principal identified the need to provide administrators with training on conducting effective instructional coaching, conducting classroom observations, feedback, and reflection cycle, to ensure that strategies taught to teachers during professional development/learning are implemented with fidelity to improve student outcomes, engagement, which impacts attendance, and academic progress.
- Other School Personnel– COVID Task Force took place weekly both virtually and in-person. Discussions took place on COVID testing protocols and procedures, progress reports, infection rates/quarantine, parent events, staffing, Panorama survey results, and use of one-time funds.
- Parents including those representing Unduplicated Pupils (UP) and Students with Disabilities (SWD) stated they would like to be able to volunteer onsite; and for the

school to communicate using communication tools (email, text, Remind app, etc.); and a return weekly Friday folder. Parents would like additional targeted intervention for their child that is struggling academically (significantly below grade level) in mathematics and reading; and opportunities for after-school tutoring.

- Students including Unduplicated Pupils and Students with Disabilities (SWD) would like clubs on campus and access to more elective options.
- ELAC would like the school to improve communication about English learners, reclassification rates, continued supports from a credentialed teacher (to teach designated ELD), and academic expectations.
- School Site Council (SSC) including parents of UP and SWD: would like workshops on SEL/mental health needs and strategies to identify and address bullying

Action 1: We did not meet the qualified teacher retention goal for this year. Upon a return to in-person teaching our instructional team members experienced a variety of professional growth opportunities, moving out of the state and leaving the profession of teaching. All teachers that were hired for the 21-22 school year were retained 3/3.

Action 3: Our staff participated in a variety of off-campus professional training courses. We had three staff members attend the CUE conference which introduces teachers to technological resources. The participating teachers brought back their experiences and information and shared learning opportunities with the staff.

Action 2: Monthly Social Emotional Wellness coaching activities were incorporated into our professional development calendar and proved effective in retaining existing staff. The instructional team participated in 10 training sessions throughout the year. The engagements were consistent and staff became familiar with the strategies and tools available that promote wellness throughout our team.
