




This chart shows the total general purpose revenue Para Los Niños - Evelyn Thurman Gratts Primary expects to receive in the coming year from all sources.



# **Plan Summary 2023-2024**

#### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Since 1980 Para Los Niños has worked to support children in their journey towards a more successful future. Para Los Niños provides comprehensive and integrated educational and family services that support the whole child from infancy through successive stages of school and life. Para Los Niños Gratts Primary Center provides transitional kindergarten, kindergarten, first grade, and second grade. Families enrolled at Para Los Niños Gratts Primary Center have access to a wide range of services provided by Para Los Niños. We understand that in order for our students to be successful academically their physical and emotional needs must be supported both at school and at home. Para Los Niños offers qualifying children, and their families support through the following programs: Clinical Services PLN provides ongoing mentoring, problem solving, and socio-emotional support for children struggling through transitions, difficulty managing emotions, feelings of depression/anxiety and victims of community violence. Our approach is evidence-based, family and child centered. Para Los Niños Gratts Primary Center, serving the children of working families in downtown Los Angeles, strives to cultivate and to celebrate the potential within each child and equip students with skills, knowledge and confidence necessary to pursue excellence and succeed in a multi-cultural world.

Through a relationship-based approach and Multi-Tiered System of Support, we provide an educational program that addresses academic, social and emotional learning and, ultimately, the wellness of our students. We have an intense focus on the whole child, understanding that children live and learn within the context of a family, and a family lives and learns within the context of a community. As part of a non-profit organization, we strive to personalize our educational approach for every student by providing comprehensive and accessible support in our schools which begin from infancy and range to middle school. We are in constant pursuit of accelerated learning, through assessment and data-driven data decision-making. Through an interdisciplinary, arts-infused approach to mastery of grade level standards, our students – the overwhelming majority of whom are English Learners – are provided with multiple ways to succeed and express their learning.

#### **MISSION**

The mission of the Para Los Niños-Evelyn Thurman Gratts Primary Center is to help children and their families succeed in school and in life. In keeping with the vision for Para Los Niños as an organization, our school is a center for urban education providing students and their families with all the support and tools necessary to ensure academic success.

#### **Reflections: Successes**

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Para Los Niños Evelyn Thurman Gratts has a lower Chronic Absenteeism percentage across all students and numerically significant student groups. Gratts had 9.7% absent 10 percent or more of the instructional days they were enrolled compared to the State at 30%. Though Gratts holds a significantly lower percentage than the State, the objective is to continue decreasing the percentage of chronic absenteeism in all students. At Gratts, when a student is chronically absent, several support actions are taken. The school's Family Specialist contacts families to better understand the absences and to offer any support items that may be available (ex. TAP card for public transportation). Subsequently, the family meets with the principal regarding the importance of school and the impact absences have on academics. Resources from Attendance Works website provide visuals and helpful information for families. Families are then placed on an attendance tracker to continue to support them. Finally, the goal is to decrease absences and ideally prevent students from being chronically absent. Student Site Council and Learning with the Principal are spaces used to educate families on the importance of attendance in the hope of preventing chronic absenteeism.

Para Los Niños Evelyn Thurman Gratts had 0.4% of students suspended at least once compared to the State's percentage of 3.1%. Gratts' significant student groups are also lower than the State's percentages. Gratts is committed to implementing restorative approaches when addressing student choices that are not in alignment with our expectation. Throughout the school year, classrooms spend time learning about social-emotional well-being and practicing putting it into action. There are opportunities for students to be part of social skills groups with the school's social worker. If current support does not meet the needs of the student, Gratts works as a team with the family, teacher, and outside support to provide the necessary support. The goal is for all students to work through any conflict and receive the necessary resources.

In math, Para Los Niños Evelyn Thurman Gratts averaged -29.9 compared to the State's average of -51.7. Gratts averaged 21.8 percentage points better than the State's average, which is a significant difference. Gratts strives to continue closing the gap with new and improved systems in place for the 2022 – 2023 school year. Following a similar model from ELA learning academies, Gratts added three math learning academies cycles that will focus on mClass math skills and grade level standards. Due to being a new system, data dialogs and professional development will occur throughout the school year to support the staff's growth on the subject. Gratts will also add math progress monitoring to its expectations to track students' growth. With the new additions, Gratts managed to increase the percentage of student at benchmark from 12% (BOY 2022) to 41% (MOY 2023) exceeding last 2022's EOY by 10%.

#### **Reflections: Identified Need**

In ELA, Para Los Niños Evelyn Thurman Gratts Primary Center (Gratts) averaged -37.4 compared to the State's Average of -12.2. Recognizing that Gratts was 25.2 percentage points aware from stand, the school has implemented improved systems for the 2022 – 2023 school year. To continue supporting students, Gratts will complete three ELA learning academy cycles during the 2022 – 2023 school year. Learning academies are tier-one interventions designed to support skill growth based on mClass skills and grade level standards. Before each cycle, there are scheduled school-wide data dialogs to deepen staff's understanding and set goals as grade levels. In addition, teachers select target students for the trimester to track student growth. As a school, progress monitoring with fidelity will continue to be part of the expectation. With the current improved systems, Gratts increased the percentage of at or above benchmark students from 36% (BOY 2022) to 49% (MOY 2023), which already surpasses the 48% of at or above the benchmark of EOY 2022. Finally, there are no numerically significant student groups to report on for ELA.

In the English Learner Progress Indicator (ELPI), Para Los Niños Evelyn Thurman Gratts averaged 45.3% compared to the State's average of 50.3%. At Gratts, 32% of students progressed at least one ELPI level, and 36% of students maintained their ELPI level. Gratts has the opportunity to continue growing while closing the gap among its ELs. In the 2021-2022 school year, learning academies and fall/spring interventions were created to address the learning gaps created by COVID-19. Gratts will continue to provide intervention to students in addition to providing support to staff and families.

For the 2022- 2023 school year, Gratts has continued to provide tier-one interventions through learning academies to all students including ELs. The goal is to address reading and writing foundations to fortify skills needed in ELPAC Summative. Current data reflects a correlation that previous and current interventions have increased ELs who are at, and above, benchmark compared to the previous school year (37% MOY 22 vs 51% MOY 23). Gratts will continue to monitor ELs in mClass.

Additionally, Gratts' ELPAC coordinator has provided a language acquisition intervention to support the language development of EL students. For staff, they will continue to develop how to best support ELs throughout the day and imbed strategies throughout all the subjects. Furthermore, the ELPAC coordinator provided ELPAC training to ensure teachers are familiar with ELPAC domains and calibrated for scoring ELPAC Summative 2023. Finally, SSC, ELAC, and Learning with the Principal have provided a space for families to learn more about ELs. Families have learned about ELPAC and the process of reclassification. Families have also taken resources home to

support their child's reading and writing skills. Gratts goal is to continue supporting ELs to increase the ELPI percentage.

# **LCAP Highlights**

Regarding LCAP Goal #1, teachers have continued to develop their error analysis skills in ELA and Math. In addition, as a school, the staff has continued to progress monitor and adjust instruction as needed. Teachers also have more autonomy on topics covered in professional development to further their skill sets and interests. Instructional aides participate in all-day PDs to develop their skill set and do have a dialog about data with their assigned teachers. A challenge has been the change of personnel. Gratts no longer has an Intervention and Assessment coordinator and has fewer Instructional Aides. Gratts has been flexible with the changes and is working on finding a balance to continue making progress towards LCAP goal #1.

Regarding LCAP goal #2, social skills groups and positive behavior assemblies have consistently been scheduled and have supported the positive school environment. Parent workshops occur at least once a week with the support of the Family Specialist. Also, "Learning with the Principal" has become part of a monthly recurrence. A challenge for LCAP Goal #2 would be the percentage of parents participating in the workshops. We currently average 3-5% of parents participating weekly, which is significantly lower than in previous years. As a school, Gratts is exploring better ways to promote events, and identifying topics of greater interest to parents.

Regarding LCAP goal #3, teachers continue to practice the review of grade-level standards to guide their instruction. Teachers use the standard-based report card during their grade-level meetings for long-term planning for the trimester. As of MOY 2023, 49% of students are at and above the benchmark, therefore EOY is predicted to be higher than the previous school year's data.

## **Required Descriptions**

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

The LEA serves a student population that is nearly 87% free or reduced lunch eligible and 54% English Language Learner. Students in these groups make up a significant number of our overall student population and their respective needs are always considered when the LEA is making programmatic decisions. For example, many of our Foster Youth students have lacked stability in their educational journeys, often switching school more frequently than their non-Foster Youth peers. To support this population of students the LEA has invested in additional staff (e.g. teachers, administrators, classified staff, and mental health staff) to reduce the student-staff ratios and increase the likelihood that every child has a positive relationship with at least one caring adult on campus. A subset of these additional staff sit on our School Support Services Team and are responsible for identifying Tier 2 academic, attendance, and social emotional supports for students.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

To better support foster youth, English learners and low-income students in the 2023-24 school year, the LEA will be investing in a new data analysis platform from Panorama called Panorama's Student Success Platform. The platform will enable the LEA to see intersectional data. like FRL and ELL status, and assign and monitor Tier 2 interventions for all sub group populations. In addition to the costs associated with purchasing the program, the LEA will use LCFF funding to cover the costs associated with the staffing needed to effectively implement these RTI models.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

The LEA will receive \$73,908 in concentration grand add-on funding. These funds will be used for staffing that provides services to our foster youth, English Learners, and low-income students. Examples of the planned expenditures include staffing an additional adult (e.g. Instructional Assistants) in all classrooms to support small group work with English Learners, a Family Specialist to liaison with our Foster Youth families, and a Student Success Coordinator who arrives on campus as early as 7:00 am to provide supervision for students of low-income working families that need the additional supervision to accommodate their work schedules.

The LCAP development process serves three distinct, but related functions:

- Comprehensive Strategic Planning: The process of developing and annually updating the LCAP supports comprehensive strategic planning (California Education Code [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. ## **Goals and Actions**

However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
